### Class Description and Objectives

The long-term objective of this course is to aid practicing engineers in materials selection and design by understanding the interplay among structure, processing, properties, and ultimately performance. This course provides a broad coverage of the field and serves as the introductory course in the major field.

**Weekly Homework:** Problem sets will be posted on PrairieLearn. It is the responsibility of the student to complete them outside of class. Each problem will have a set number of attempts and points awarded. The lowest homework score will be dropped.

**Late Homework:** For homework, there is a -10% penalty for every 24 hours late, to a maximum penalty of -60% if submitted before Reading Day.

**Exams:** Two exams and one final will be given on PrairieTest through the Computer Based Testing Facility (CBTF). CBTF allows students to choose a time slot that works best within a set window. Exam 1 will be offered Feb 26-28, Exam 2 will be offered Apr 16-18, and the final exam will be offered during finals week. Sign up for exam time slots begin Feb 12 (Exam 1), Apr 2 (Exam 2), and Mar 13 (final exam). A formula sheet will be provided for the exams.

**Makeup Assessments:** This is at sole discretion of the instructor and requires timely reporting of the absence by the student. For planned absences, notice must be given to the instructor at least 7 days prior to the start of the assessment, with the expectation that the exam will be taken prior to the planned absence.

For excused and verified absences due to illness or other unexpected/unplanned event, a makeup quiz will be available for full points if it can be administered in a timely manner. If, due to the absence, this cannot occur, a "0" will be given as a temporary grade, with the final replacing this score at the end of the semester.

Late penalties on homework may be eliminated or adjusted and will be dealt with on a case-by-case basis.

**i>clicker extra credit:** i>clicker will be used during class to facilitate discussion and will grant up to 10 extra credit percentage points to the final exam score. To receive the full 10 extra credit percentage points, students must answer the majority of questions in >85% of the lectures. Less than 85% will prorate the extra credit accordingly. Note, if the i>clicker app is used, this is the "points" score, not attendance.

**Re-grading Policy:** For simple addition/subtraction errors on points awarded, please bring up the assignment or exam after class or stop by during office hours. Any other request requires a cleanly written explanation that includes your name, assignment or exam, problem in question, and a written description describing the mis-grading and why a re-grading is warranted. Any attempt to "doctor" or manipulate the assignment will be dealt with under the Student Code.

**AI Usage Policy:** The use of AI is broadly accepted for generating ideas and exploring options. Students must document the version of AI utilized and the input prompts. AI must not be used to create portions of reports or homework. The goal is for students to synthesize the AI output and create something new. Refer to specific assignments for details and discuss with the instructor with any questions or concerns.
