Learning Goals:

- Establish a baseline understanding of the current state of sustainability in the aviation industry
- Instill "sustainability thinking" for use on future complex, multi-disciplinary problems
- Relate high-level ideas of energy, power, propulsion, operations and systems design
- Understand and model implications of power and energy life cycles
- Demonstrate technical independence and effective communication of critical ideas

Assignments and Opinions of the Court:

Assignments will be made approximately once every week and will be due at the beginning of class. These assignments will alternate between individual quantitative problem-solving prompts and team-based Opinions of the Court prompts.

Quantitative problem-solving assignments are to be performed on an individual basis, with unique submissions from each student. Solutions for quantitative problems will be posted immediately following class, so no late assignments are accepted. While collaboration with classmates and colleagues on assignment is encouraged, all students are expected to turn in his or her own work. Submitting the work of another as one's own, or facilitating such a submission, is considered an infraction of academic integrity as outlined in the Student Code (<u>http://studentcode.illinois.edu/</u>).

Opinions of the Court assignments will be performed across assigned teams, with a single submission required for the entire team. This process is inspired by the "opinions" framework utilized by the US Supreme Court (https://www.supremecourt.gov/opinions/opinions.aspx). When responding to a prompt, the team is required to compose a consensus perspective, which will be summarized into a document with length of 500 words or fewer. In a separate section, similar to documenting dissenting opinions by the US Supreme Court, each team member must individually clarify their stance on the team consensus perspective. This latter section is limited to 200 words per individual, and it is intended to provide further nuanced details on areas where you agree, disagree, support, or dissent from the consensus view. If you support all aspects of the consensus view, provide specific and unique examples of its relevance and/or application. All opinions will be posted publicly for the class to see.

Term Project: A term project prompt will be provided in October. This project is intended to demonstrate the formation of a critical sustainability framework and application of analysis skills developed throughout the course of the class. This project will be performed in assigned teams.
