**In-lecture worksheets:** Worksheets will be posted on Canvas prior to the lecture. These will be (usually) completed during class. Completed worksheets should be submitted via Canvas; due dates are a few days after the lecture to allow completion. Tuesdays' worksheets will be graded upon completion; Thursdays' worksheets will be graded on accuracy. The lowest worksheet score will be dropped.
