Learning Goals:

- Establish a baseline understanding of the current state of sustainability in the aviation industry
- Instill “sustainability thinking” for use on future complex, multi-disciplinary problems
- Relate high-level ideas of energy, power, propulsion, operations and systems design
- Understand and model implications of power and energy life cycles
- Demonstrate technical independence and effective communication of critical ideas

Assignments:

Assignments will be made approximately once every two weeks and will be due at the beginning of class. These assignments will alternate between individual quantitative prompts and team-based problems. Submissions should be provided in PDF format, including all work, figures, and codes used for the assignment.

Quantitative problem-solving assignments are to be performed on an individual basis, with unique submissions from each student. While collaboration with classmates and colleagues on assignment is encouraged, all students are expected to turn in their own work. Submitting the

work of another as one's own, or facilitating such a submission, is considered an infraction of academic integrity as outlined in the Student Code (<https://studentcode.illinois.edu/>). Submission of solutions, including hand/computer calculations or codes, that are perceptibly identical across multiple students is considered a cheating violation of the Student Code.

Design or systems-oriented group assignments will also be made throughout the semester. Groups will be assigned based on self-assignment on the course Canvas page, or by instructor. After forming, groups are expected to develop a consensus operational and participation policy, which is documented and provided with the first group assignment. Submissions should address items requested in the assignment prompt, and only one member is required to submit the completed assignment on behalf of the group. All group members are expected to actively participate in the process of these assignments per the stated group policy, though the instructor can be contacted in the event of disputes related to group work.

Lecture Participation:

The learning goals of the course related to sustainability thinking are best achieved with active engagement from students. Periodically, the class will be presented with interactive prompts to encourage open and informal dialogue. A series of polling questions will also be provided to obtain the thoughts and perspectives from the students enrolled in the course. Responses to polling questions are expected within one week from the lecture that they are first introduced.

Term Project:

Term project prompts will be provided in October, with separate projects for 3-credit and 4-credit registered students. This project is intended to demonstrate the formation of a critical sustainability framework and application of analysis skills developed throughout the course of the class. This project will be performed in assigned teams.
