Course Objective

Networks and graphs have become an indispensable ingredient in a variety of data mining and machine learning problems with numerous applications. This course will provide an in-depth understanding of graph machine learning algorithms, and their applications in a variety of real problems. It aims to provide a comprehensive and in-depth introduction of the fundamental principles and techniques of graph machine learning.

- Be able to understand the key concepts and underlying principles of graph machine learning techniques, including graph proximity, matrix and tensor, graph neural networks, graph connectivity, network of networks.
- Be able to apply the key graph machine learning techniques to realistic setting, evaluate and analyze the analysis results.
