Course Description:

Thermodynamics is the foundation of thermal sciences and is widely used in the analysis and design of engineering systems. This course provides a thorough introduction to the fundamental concepts of thermodynamics, including thermodynamic systems and their behavior, thermodynamic properties, and the first and second laws of thermodynamics. Instructional materials, learning activities, assignments, and assessments are designed to develop systematic problem-solving skills from a thermodynamic perspective. The instructional team is committed to supporting students' learning and preparing them for future real-world engineering challenges. Prerequisite: MATH 241.

Topics:

- 1) Introduction (thermodynamics, systems, specific volume, pressure, and temperature)
- 2) Thermodynamic Properties (p - v - T relation, u , h , s , retrieving and evaluating properties, and ideal gas model)
- 3) The First Law of Thermodynamics (amount and rate of energy analysis)

- 4) The Second Law of Thermodynamics (direction of processes, irreversibility, entropy production, amount and rate of entropy analysis)
- 5) Typical Energy Conversion Systems (Vapor power plants, internal combustion engines, gas turbine power plants, and vapor-compression refrigeration systems)

Objectives:

At the end of this class, students will be able to:

- 1) Identify and explain the concepts of system and its behaviors from the viewpoint of thermodynamics.
- 2) Identify and explain the concepts of various thermodynamic properties, as well as retrieve and evaluate the thermodynamic properties of interest.
- 3) Apply the first law of thermodynamics to conduct the amount and/or rate of energy analysis for components and systems of interest.
- 4) Identify and explain the irreversibilities in real-world processes; apply the second law of thermodynamics to determine the direction of processes and the best theoretical performance of cycles, components, and systems by conducting the amount and/or rate of entropy analysis.
- 5) Identify, explain, and analyze the performance of typical power and refrigeration systems by applying the first and second laws of thermodynamics.

Classwork:

Classwork is usually polling questions performed via iClicker and the completion grade will be assigned to classwork. The iClicker classwork will also be used to check attendance. Zero points will be given for the classwork assignment if you miss the lecture. You can email me ahead of time to request a leave of excused absence and in this way you can be exempt from classwork. There might be opportunities to earn extra classwork points, which can be used to compensate for points lost on classwork assignments but cannot be applied to any other assignments or exams. Two classwork assignments will be dropped off.

Homework:

Homework must be an electronic version in a single PDF file and must be submitted on the course website via Canvas. Homework must be submitted on time. An extension of one day can be automatically granted, but it will be accompanied by a 20% reduction in your score. No homework will be accepted after an extension. Homework will be graded on correctness. Your work must be neat and complete to receive full credit. “Complete” means (1) “Known”, “Find”, “Schematic and Given Data”, “Engineering Model”, and “Analysis” must be presented in your solutions; (2) all the steps showing how you reach your final answer must be presented in “Analysis”; (3) if a system is involved in your analysis, how the system is defined must be presented in your work; (4) the steps of plugging the given numbers with units into the equations must be presented in your work and the units must be presented for the numbers of results; (5) words must be used to explain your thoughts, not just equations. There might be opportunities to earn extra homework points, which can be used to compensate for points lost on homework assignments but cannot be applied to any other assignments or exams. No homework assignments will be dropped off.

Quizzes:

A quiz will be administered during the last lecture meeting of each chapter for Chapters 2 through 7. (During the last lecture meeting of Chapter 1, a practice quiz will be conducted as a classwork assignment to familiarize students with how the quizzes will be administered.) Students who miss an in-class quiz without the instructor’s approval for an excused absence will receive zero points, and no makeup quizzes will be offered. Students who miss an in-class quiz with the instructor’s approval for an excused absence will be offered a makeup quiz. Each quiz consists of true-or-false and multiple-choice conceptual questions. The best way to prepare for the quizzes is to review the lecture notes and the problems in the textbook section titled “Checking Understanding.” Quizzes will be graded based on correctness. Students may retake each quiz once through the Canvas course website within the designated time frame. A one-day extension for the retake may be automatically granted, but it will result in a 20% score reduction. No retake quizzes will be accepted after the extension period. If a student retakes a quiz, the final quiz grade will be calculated as a weighted average: 90% of the higher score and 10% of the lower score. No quizzes will be dropped off.

Exams:

All the exams will be closed-book exams. The tentative schedule for the exams can be found in the teaching calendar. The students who need the accommodation of extra time for exams must schedule and take their exams at the DRES TAC (Testing Accommodations Center of Disability Resources and Educational Services). Please complete scheduling the exams at the DRES TAC as soon as possible, especially for the final exam, since the DRES TAC may not accept your application and schedule when they reach the capacity limit. If students fail in scheduling exams at the DRES TAC, they must attend the regular exams without the accommodation of extra exam time.

Excused Absence and Submission Responsibility:

The excused absence from class and the late submission beyond a one-day extension can be considered only if you ask for leave or an additional extension in advance. It is the

student's responsibility to make sure of a successful submission of their work. After the submission of your work on the Canvas course website, please immediately check if your work has been submitted successfully. If not, please redo the submission. If the resubmission online fails, you must email me your work for submission, as well as the evidence of the work completion on time, by the following day of the due date. The instructor will decide whether the work can be accepted or not. It is also the student's responsibility to make sure that their work is submitted correctly and completely. Zero points will be assigned for a wrong submission. No resubmission will be accepted for an incomplete submission.
