





FIRST NAME has strong medical knowledge and is very enthusiastic to learn and work hard. They will make a very good resident in the future. • FIRST NAME did very well in their first clerkship of the major clinical year. They presented H&Ps and daily progress very well. They had a good understanding of their patients' issues and

proposed rational plans. FIRST NAME did a thorough presentation for the residents on the team on the monitoring and treatment of acute alcohol withdrawal. Worked really well with the rest of team. • FIRST NAME was a welcomed addition to our team caring for medically complex patients who were in our step-down ICU and general medical floors. They have a solid foundation of medical knowledge and were able to identify the most likely diagnosis and formulate a differential diagnosis for their patients. Their oral presentations were logical and concise, and they did a good job following the SOAP format. They formulated thoughtful clinical questions to investigate. They gave a nice presentation on the workup of acute kidney injury in hospitalized patients. They connected well with patients and have great communication skills. They adapted very well to our team structure, was engaged with caring for and learning from all patients, not just their own. They got along well with their senior residents and demonstrated a growth mindset by being very open to feedback, seeking specific feedback on their oral presentations, and incorporating that feedback with noted improvement almost immediately. • Very impressive performance during their IM rotation. They were selfmotivated, inquisitive, and posed thoughtful questions. They stood out in terms of patient interactions: They comforted a very distressed patient diagnosed with acute pancreatitis at the bedside. They also presented on alcohol withdrawal really well (with background research data). • FIRST NAME performed beyond the expected level for their training. They displayed a great deal of curiosity and zeal for knowledge and asked excellent questions. • They were professional with the team and personable with patients and staff. • FIRST NAME was a pleasure to have on our team. They were knowledgeable, thorough, thoughtful and focused. Overall, a great team player. 

I allow them to discuss results and plans of care with their patients, and they have proven adept at making strong connections and communicating things well. They also presented a couple topics to the team and was quite thorough; they gave meaningful information that was evidence-based. • FIRST NAME did an excellent job during their adult medicine rotation. 





#### IDEA (March 2022 - March 2023) Overall grade based on:

This course focuses on bringing engineering solutions to clinical problems. Examples of FIRST NAME's work include:

- Recognizing the lack of patient clarity regarding their hospital course/discharge plans, FIRST NAME developed a patient-facing user interface that would foster higher rates of in-patient plan comprehension and post-discharge compliance.
- After identifying the need for improved ostomy management in colorectal surgery clinic, FIRST NAME created a 3D CAD model of an implantable ostomy port to minimize cutaneous irritation, infection, and leaks.
- While caring for post-partum mothers struggling to maintain sufficient breast-milk supply, FIRST NAME was able to generate schematics of a more efficient breast pump that physiologically mimics a newborn's oral biomechanics.

Additionally, Carle Illinois students distinguish themselves with an innovation capstone by researching a problem identified during their clinical rotations, propose a solution, and then recruit and lead a cross-disciplinary team to develop a new prototype or process that will potentially change the practice of medicine and improve patient outcomes and a data science project. Additional information about FIRST NAME's distinguishing attributes and significant recognitions:

- **Recognition:** Clinical performance in the top quartile of their graduating class. He earned the "clinical honors" grade designation for every clerkship during their clinical years.
- **Data Science Project:** FIRST NAME's data science study assessed the post-operative outcomes of preterm neonates delivered via cesarean section.
- **Capstone Project:** FIRST NAME's capstone engineering project developed a cloudbased application connecting patients to optimal group therapy options based on individual characteristics.
