

Rebuild Illinois - \$45 Billion Capital Program




FY 2026-2031 Multi-Modal Multi-Year Improvement Program




FY 2026-2031 Highway Improvement Program FY 2026-2031 PROGRAM DISTRIBUTION

PA 103-0589 – \$400M for Local Project Funding


223 projects identified from over 1,900 applications



Innovative Project Delivery (IPD) Procurements

On occasion, the Chief Procurement Office oversees projects within its jurisdictions that are not a part of the regularly scheduled Highway Lettings.

This invitation is the official advertisement and solicitation for Request for Information (RFI), Request of Qualifications (RFQ) and Request for Proposals (RFP) issued by the Illinois Department of Transportation (IDOT). With oversight by the Chief Procurement Office, this bulletin is published to secure alternative methods of deliveries including **Construction Manager/General Contractor (CMGC)**, **Progressive Design Build (PDB)**, **Design Build (DB)**, and **Public-Private Partnership (P3)**. The Illinois Procurement Code requires the Chief Procurement Officer to provide information to the public concerning IDOT's procurements and procurement-related activities. Information includes, but is not limited to, awards, change orders, reports to the General Assembly, contractor suspensions, DBE waivers, conflict of interest statements, and emergency procurements.
